Special Use Permit for Valerie Vattimo for home occupation in an accessory building

- ➤ Valerie Vattimo wants to open a dog grooming business in her detached garage thus requiring a special use permit because of the detached building.
- ➤ SEQR has been submitted, along with sketch plan. Since it is within 500 feet of agricultural it needed to go to the county. The County Planning Department determined that it has no significant countywide or inter- municipal impact.
- Sixteen letters notifying Valerie's neighbors were mailed notifying them of the public hearing. No neighbors appeared for the hearing
- ➤ Dave Russo moved to close the public hearing at 7:15 p.m., Mark Vitale seconded, all in favor, carried.
- Mark Vitale moved to approve the special use permit for Valerie Vattimo's home occupation, Davie Nagel seconded, all in favor.

Review of October 16 minutes

- ➤ Davies Nagel questioned two items on page 4 he meant sent dates of planning board to calendar on website and change the wording of the vote to Motion passed
- Joe McIlroy moved to approve the minutes, Dave Russo seconded, all in favor, carried

Second public hearing regarding the pizzaria/restaurant needs a sketch plan for parking. Because the property has been empty it goes back to commercial piece of property.

- According to our zoning every 1000 ft. would need 10 spaces of parking. However because of #519, section D in our zoning the planning board can deviate from that for on the street parking.
- ➤ Carol Ell it would be nice to have a restaurant in town
- ➤ Carl Sick just doesn't want his driveway blocked like in the past by employees

- ➤ Art Bernecker questioned about fryers and ansul system. Brenda they were already there
- ➤ Carl Peter stated that Brenda & Jamie had already had the health department walk through to see what was needed
- Art Bernecker concerned about his tenants parking in front. Dave Russo asked if signs could be put up for the post office. Jerry Deming said that since it was state property the signs would to go through the state
- ➤ Irene Sick asked if there would be any employees. Brenda & Jamie said possibly
- Art Bernecker asked if the town could put in a driveway around the back of the buildings. Jerry Deming stated that the town cannot improve private property.
- Mark Vitale asked if there would be a dumpster and the answer was yes.
