Planning Board Minutes April 12, 2016

Chairman McIlroy opened the public hearing at 7:30 pm with the Pledge of Allegiance.

Mr. McIlroy gave Mr. Fuller the floor. Mr. Fuller asked if everyone had read his letter regarding the March 8 meeting. The board had read the letter.

Mr. Campbell, regarding meeting times, the official published time is 7 p.m. but the webmaster had mistakenly listed it as 7:30 p.m. The issue will be taken care of.

Mr. Fuller asked if the March meeting was legal. Mr. Campbell responded that that meeting would be done tonight because Mr. Fuller was correct about the alternate members. Although the board thought it was ok to use alternates, a local law was never done saying alternates could act in any capacity other than a conflict of interest.

Mr. Fuller asked how the planning board could act on a wild card.

Mr. Campbell explained that the application is the beginning process and more discussion takes place after that and there will be adequate water. There will be sewer but whether it will be in house or improvements will be made to adapt for the increased capacity is yet to be determined. We have gotten commitments from Geneseo for the water. As far as the site plan and special use permit, the board has enough details to approve the site plan. Other improvements will be off site. The wild card is no longer such, because discussions have ensued to handle it.

Mr. Fuller said that it is a large conglomerate with several conglomerates involved in Project Gardens with Chris Noble at the head.

Mr. Campbell said it is a conglomerate from a business standpoint. A different realm for site plan approval – we're concerned about the large conglomerate, not each individual group.

Mr. Fuller said we don't get any information from Town Board – Chris Noble stood here and said they didn't need any town water.

Mr. Campbell – They don't! The project works for everyone.

Mr. Fuller was concerned that when the cheese factory goes in with all the infrastructure, taxpayers will pay for it.

Mr. Campbell – Project Gardens will be paying for water into the district a bigger pro-rated amount. When the present sewer system gets old and needs repairs who will pay for it. Project Gardens might be saving taxpayers from future repairs on their dime to the present sewer system.

Mr. Fuller – Back when the salt mine collapsed and the water line was put in, the comptroller in Albany set the figure the people would pay for 20 years.

Mr. Campbell – Every year those thresholds change – people's systems are not working good and changes have to be made. No one is bound by numbers after the first year.

Mr. Fuller – You did the SEQR different than Rick Henry did the one last month where he gave the answers.

Mr. Campbell – You rely on the professional people for some things. The answers should be the boards, but there is a balancing act, you get knowledge form the experts. Mr. Campbell wasn't at the March meeting but before that there was a lot of information looked at and the process was slowed down by the town. N town is pretty good at fulfilling their duty.

Mr. McIlroy stated that the website would be taken care of and the alternates need to be addressed with the town board.

Mr. Campbell – You live and learn. You need to validly have alternates because not everyone can be here all the time. Need to add greater purpose to alternates to take care of business when it comes up. The Town Board would need to consider adopting a local law to change the alternates' role.

Mr. Fuller – Why isn't the water line and sewer line being run together?

Mr. McIlroy – so it will benefit more people.

Mr. Dermody – to benefit more people, especially those in Linwood.

• Minimize use of jake brakes – applicant will notify all drivers and post on property that jake brakes be minimized within the town of York

- Facility shall meet all performance standards as identified in section 516 of zoning ordinance
- All signage and lighting shall meet requirements of zoning ordinance

Amendment will only be for the cheese factory.

Planning Board cannot specify weight limit – that requires legislative action.

Mrs. Grant said she keeps thinking about the odor, pg. 34 #5 in zoning – in the performance standards
