On Tuesday, March 28, 2017, the Planning Board will hold a special meeting in place of the March 14th meeting that was cancelled at 7 p.m. at the York Town Hall, 2668 Main St., York, N.Y. and also for a public hearing for the purpose of a proposed site plan and special use permit for the installation of a Sky Wolf Hybrid Solar Wind Turbine at Joseph Eyer's at 2330 Cowan Road in the Town of York. All are welcome to attend.

Mr. McIlroy asked for public comment:

- 1. Mr. Wolcott asked what the height of the tower was and what the noise level would be. Mr. Brock answered the tower was 32 ft. high and 25 ft. to the center of the hub. He said a car driving down the road makes more noise.
- 2. Mr. Campbell asked if he intended to fence the area. Mr. Brock said it did not require a fence. Mr. Campbell said that if you didn't want to fence it (according to zoning) he would have to submit a letter that you don't want to fence the tower and the reasons why tonight.
- 3. Mr. McIlroy said that the town's zoning requires a 6 ft. fence. Mr. Brock asked the board to forego the fence. Mr. Campbell again said that it would have to be a written request to the board and why it doesn't need it. Mr. Brock said all the safety measures are in place, they're visually pleasing, run quiet and pivot into direction of wind.
- 4. Mr. McIlroy asked why in the front lawn and not the back. Mr. Brock said the wind is blocked in the back yard and is not blocked by anything in the front yard.
- 5. Mr. Richenberg asked if it has an excessive wind speed detector. Mr. Brock replied yes and it brakes at about 35-40 mph. It's 100 feet from the house and 50 feet from the property line.
- 6. Mr. Dermody asked how far from the foundation was the emergency shut off and if its lockable how does someone get to it in an emergency. Mr. Brock said it was 5 feet and lockable, when

- there is a failure on the power grid it shuts down automatically. Mr. Brock said that even if it's shut off by someone there's no harm done.
- 7. Mr. Wall asked what the purpose of a fence was. Mr. McIlroy read what the code says, p. 71 Mr. Brock said there's no safety issues involved. Mr. McIlroy said there is always a safety issue when there is something spinning or involving electric.
- 8. Mr. Dermody asked if power was buried in conduit and Mr. Brock answered yes.
- 9. Mr. Richenberg asked about a fence at York Animal Hospital. Mr. Peter said the hospital was in the process of creating comment on why they don't need it.
- 10. Mr. Richenberg said that public utilities don't have fence. Mr. Campbell said we don't have the ability to regulate them. In terms of access any creative kid can get to anything. Mr. Brock said there is no potential exposure to electrical shock.
- 11. Mr. Geiger, from a fire and rescue side, if everything is contained he doesn't see a safety issue in climbing a smooth pole.
- 12. Mr. Dermody asked where the animal hospital stands. Mr. Campbell said there is a compliance issue right now and have to come back for amended site plan.
- 13. Mr. Campbell said that with the highest point of Sky Wolf being 32 feet, the set back of 50 feet is ok.
- 14. Mr. Wolcott would prefer not to see a fence just one more thing to look at.
- 15. Mr. Campbell asked is the board has any other safety issues.
- 16. Mr. McIlroy referred to H-7, p. 70 regarding viewing area. Mr. Brock placed the tower there because of unobstructed wind. Mr. McIlroy asked why it couldn't be in the back the hedgerow goes all the way to the road. Mr. Brock said it's not the hedge trees obstruct it that are in the back hedgerow, none in front. Mr. Wolcott said he'd rather see it in the back but Mr. Brock is right, the hedge is thicker and higher in the back.
- 17. Mr. Peter asked why the house didn't block the wind. Mr. Brock said the tower is strategically placed to catch the prevailing winds. Mr. Wolcott said the tower would be higher than the house.
- 18. Mr. Brock said that the tower in Livonia has been up for five years and there hasn't been any maintenance on it.
- 19. Mr. Campbell asked for any other comments.
