7:30 pm – Mr. McIlroy opened the planning board meeting and led the pledge. The May minutes were tabled until the July meeting because Mr. Brabant and Mr. Campbell did not respond to Ms. Falkner's questions about several sentences.

To the York Planning Board,

First, I would like to commend you for requiring the proposed truck stop project to submit a full Environmental Assessment Form (EAF), rather than the short form. I believe that the proposed project warrants the highest level of scrutiny regarding potential negative environmental impacts on the health of school children, faculty, and staff, as well as neighboring residents. The best way to ensure a thorough analysis is to require an Environmental Impact Study (EIS).

In addition to significant issues of pedestrian safety due to increased traffic and new traffic patterns, the proposed project can reasonably be expected to result in substantial changes in air quality, water quality, and traffic and noise levels. The proposed project would also have an impact on residents along Rt. 63 as it traverses Livingston County, with increased traffic and the resulting air and noise pollution, including the noise, dust, and traffic interruptions that would take place during construction.

In the SEQR process, you are required to identify all relevant environmental impacts, thoroughly analyze these potential impacts, and provide a written explanation as to why you have determined whether the project may cause significant adverse environmental impacts. As you engage in this process, I urge you to carefully consider the following potential harms that could result from the proposed truck stop in our town. As SEQR regulations note, all potential impacts considered as a whole may be grounds for a positive determination, even if each individual impact would not rise to that level.

As presented, the proposed project will increase air pollution due to increased diesel exhaust, as trucks idle waiting for the light, waiting to turn left into the truck stop, while in the truck stop, waiting to turn left onto Rt. 36, and waiting to turn left back onto Rt. 63. Diesel exhaust contains particulates that are too small to be expelled by our lungs, as well as benzene, arsenic, and nitrogen oxides. It is well documented that families living next to truck stops (and children, faculty, and staff in a school next to a truck stop) are especially vulnerable to high levels of diesel exhaust. Long-term effects of breathing diesel exhaust include increased cancer, asthma, allergies, lung infections, heart problems, and emergency room visits and hospital admissions. It is recommended that schools located near significant sources of diesel exhaust have additional indoor filtration systems to protect against particulate materials. Since York Central School does not have air conditioning and windows are often open, the dangers from air and noise pollution are even greater.

Increased truck traffic and idling will also result in increased noise pollution. Research has shown that noise has detrimental effects on children’s academic performance, including reduced memory, motivation, and reading ability. It also affects teachers’ ability to teach effectively. In addition to the increased air pollution from diesel and gasoline emissions, and noise pollution from the increased truck traffic, the proposed truck stop has the potential for significant adverse environmental impacts on ground water. As currently proposed, the project would dump water contaminated with petroleum, road salt, and sediment from the stormwater management pond into Bidwell Creek. The proposed location is known to have poor drainage, which will be exacerbated by 4.7 acres of pavement.

Another consideration is the plan to cut down 3 acres of woods to make room for the stormwater management pond. This will have a significant impact on habitat for endangered and threatened species of birds known to inhabit the area.

These potential environmental impacts should be studied thoroughly before any permit is issued. The best way to ensure that all potential adverse impacts are identified and addressed is to require an EIS (Environmental Impact Statement) before making a final determination on the permit for the proposed project.

I urge the York Planning Board to make a positive declaration that the project may cause significant adverse environmental harms.
