2)County Exemption Local Law Hearing:  
Supervisor Deming informed the Board that the Livingston County Board of Supervisors

recently approved raising the exemption income limits for both the Senior Citizen's Exemptions & Persons with Disabilities and Limited Incomes. Each town and village throughout the County have the choice to follow suit with the County sliding scale limits or can maintain their own. Over the years, the Town of York has chosen to be consistent with Livingston County and asked the Board if they wish to continue to do so. The Board commented that they wish to maintain the same exemption limits as the County.

Supervisor Deming stated at our Organizational meeting on January 3<sup>rd</sup>, we will set the 2023 Town Board meeting calendar dates and once confirmed, we will schedule the Public Hearing to proceed with and required filing of this Local Law.

3)Water Tap Application:  
a-2520 Limerick Road:

RESOLUTION offered by Mr. Rose and seconded by Mr. Swede to approve the Water tap Application submitted by Catherine DeMaine for property owned at 2520 Limerick Road. Voted on and approved, Yes-4, No-0.

\*Application fee was waived due to this parcel being charged yearly water debt service on the County/Town tax bills.

4)EMS Services Letter:

RESOLUTION offered by Mr. Swede and seconded by Mr. Smith authorizing Supervisor Deming permission to sign the letter for the NYS Dept of Health allowing the York Fire Department to provide emergency medical care. Voted on and approved, Yes-4, No-0.

5)Appointments:

a) Zoning Board of Appeals:

RESOLUTION offered by Mr. Smith and seconded by Mr. Swede to re-appoint Dustin Geiger and Scott Hulburt to the Town of York Zoning Board of Appeals for an additional 5-year term. Voted on and approved, Yes-4, No-0.

\*Councilman Rose stated that he and Planning Board Chairman Joe McIlroy conducted two interviews and made the recommendation to re-appoint Chris Wall.

b) Planning Board:

RESOLUTION offered by Mr. Smith and seconded by Mr. Swede to re-appoint Chris Wall to the Town of York Planning Board for an additional 5-year term. Voted on and approved, Yes-4, No-0.

**OTHER:**

1)NYCLASS:

Supervisor Deming reported that three weeks ago he transferred money from Tompkins Bank of Castile to NYCLASS and then a week later and today as well. As a total of \$1.3

million in funds have been transferred and from the initial transfer three weeks ago, we have accrued \$1,360.42 in interest. Supervisor Deming stated that the process is simple and looks forward to being able to deposit tax collection funds shortly.

2)Minutes posting:

The Board discussed a change beginning January 1<sup>st</sup>, regarding posting of “unapproved minutes” to the website. Supervisor Deming commented that no other town or the county posts minutes until after they have been officially approved. The Board agreed to posting of the minutes to the site after approval.

3)Salt Building Discussion:

Supervisor Deming reported that he and Mr. Worden met today with an engineer from MRB to discuss and review how to proceed with plans for a new salt storage building. MRB will prepare a cost analysis for us to review and render a decision.
