Well, Yes, I literally had to go back and listen to it verbatim because you all saw the actual physical transcript, which did not make any sense what so ever. I had to physically listen to every word of the board meeting last month to document the minutes as they were spoken.

3:08- Supervisor Deming asked for a Highway Report:

#### 3:09- George Worden

We have been doing a lot of cleaning of the ditches, allowing us a good opportunity to practice social distancing because everyone is in different machinery, and getting caught up with that kind of work. We have also been mowing the cemeteries and parks this year, we did not go out to bid before all this happened so we still have the mowers luckily, and they are continuing to do that. We can revisit that at a later date or whatever the board's wishes are but will continue to do them. We started some brush pickup today. There seems to be quite a bit out there, I believe

everyone is at home and dragging it to the edge of the road, or seems like it. Should be able to finish that up tomorrow. We also hauled some stone for the County within the month for the Federal Road project. The County did grind that the other day and they have been up there working on it. We had to install a pipe in front of 3018 Federal Road for the County.

The other thing I do have on the Highway Report, we have noticed that a lot of people are walking on the Greenways and they are driving down to the Greenways. They've been using York Landing Road quite a bit and the other place I've noticed is the parking along Chandler Road quite a bit. It's kind of a fast area for vehicles, it might be something we want to visit and keep an eye on, maybe even addressing parking on one side of the road so traffic can get through easier. That's pretty much it for the Highway.

## 5:20 – Lynn Parnell

Yeah, Georgie...I know this is a County project but what is the status?, what are they doing and when will they be done up here?

## 5:20- George Worden

They ground the whole surface up, they added stone to it to make the base stronger in the road. They're grading it and rolling it, trying to get it to tighten up now. They told me they are up in the air on what their next step is going to be, whether they are blacktopping because of the funds might not be available this year through CHIPS, we're not positive on that. So, they don't know if they are going to blacktop it or oil and stone it or coal pave it. They said it would be in this status for 30 days.

6:05- Lynn Parnell...Really?

#### 6:06- George Worden

Yes, I know that doesn't make you feel warm and fuzzy about that because of that road, but it did slow the traffic down.

6:15- Lynn Parnell...not the manure trucks, they are going up and down this road like you wouldn't believe it, leaving nothing but a cloud of dust.

I will point that out to the county and see what they want to do about it. They need the traffic on there to help tighten the road back up as well. The trucks do need to abide by the construction speed limit signs, which would be a concern. I recommend calling the Sheriff's Department and make out a report.

Okay, well last week it was Donnans and this week it's M & T.

If it's M & T, if you want I can make a call and I can call Donnan's too, to make sure everyone is abiding by the speed of the construction area. I will make those phone calls tomorrow.

We have been a little bit, our State Association is tracking the CHIPS. Right now everything is there in the budget. The scary part is we all know what is happening to the budget because our Governor already said he is going to take 30% of the school's budget back, so he can pull ours back at any time. So, we could go forward and hurry to get the reimbursement made before he has a chance to pull that...it's a gamble. Or do I do half of it and see where we are at so we don't get in financial trouble.

If you could give me a list of what you want to do with the CHIPS, what your plans are and how much each section is going to cost, we'll see where we are budget wise and then what we can get done in the next two to three months and get it billed back to the State. Once it's billed back the Governor can't take it at that point, but anything unused, is my understanding, he can take back.

We did have a water leak on River Road. We had to replace a saddle down there, it was on a two inch tap. I think it had been leaking for a bit. I know we lost some water out of the deal, but I can't put a total number on it because it was unmetered water. The other thing is we have a water adjustment, which I'm sure you got, it's on your agenda, and is more water lost. Our water consumption has gone up a little bit so we're keeping an eye on it.

Yeah, we looked at it this afternoon, on the consumption and it seems to be balancing out for what we're being charged from Geneseo and what we're actually billing out. So, I think we are okay.

The sewer seems to be working okay. I did get some quotes back. I can make copies of them and maybe we can get them emailed to everyone if you want to look at them for the Gen Set down at the Tabtronics pump station. Right now it is not a big emergency at this moment because we have a generator down there that we are utilizing for that, in an emergency situation. We can actually wait if you want until next month and we can discuss it. The prices aren't going to change that much, but just so you know we are talking about a substantial piece of coin.

Anderson Road water...we did have five bidders. We opened the bids on Thursday, May 7<sup>th</sup> at the town hall. The low bidder was Morsch Pipeline in the amount of \$1,350,116.00. Out of the five bids, the second lowest was only \$2,000 difference, and all were under the \$1.8 million estimate. So, to award the bid for the Town of York Anderson Road Water District...

Whereas, the Town of York received bids on May 7, 2020 for the construction of approximately 31,000 linear feet of 6-inch and 8-inch water mains, valves, hydrants, water services, and associated appurtenances along portions of Anderson Road (County Road 45), Main Street (NYS Route 36), Limerick Road, Federal Road (County Road 50), and Linwood Road (County Road 23) in the Town of York;

Whereas, Morsch Pipeline, Inc. of Avon, NY, was the lowest responsible bidder at a cost of \$1,350,116:

Whereas, CPL has completed a review of the low bidder and the bid tabulation;

NOW THEREFORE BE IT RESOLVED, the Town of York hereby awards the bid to Morsch Pipeline, Inc. at a cost of \$1,350,116 contingent upon approval by the USDA-Rural Development and the insurance and bonding being in place as approved by the Town Attorney; and

BE IT FURTHER RESOLVED, the Town of York hereby authorizes the Supervisor to execute the agreement with Morsch Pipeline, Inc and to issue the Notice to Proceed once the Aforementioned conditions are met.

Other Business I have...after the last Planning Board meeting Joe McIlroy, Jim Campbell and myself were on the phone discussing the meeting and how unhappy we were with how that meeting went along with the engineer from TY Lin. After the very first meeting we met with the engineer from TY Lin to go over what our procedures are, what we expected him to follow and after the second meeting, they seem to not have changed at all. So, we have relieved TY Lin of the engineering for this project for Solar Park.

Jim...you're still on the phone, can you explain conversations we had with another engineer and where we are with that.

#### 22:24- James Campbell

Sure, just to clarify, we did relieve TY Lin of all responsibility for consulting engineering services, not just for Solar Park but also with regard to the pending OYA application and the Article 10, the White Creek Article 10 project that will involve the Town of Leicester as well. Following the discussions between Jerry, Joe and myself we came to the conclusion that it made sense to at least try to see if we could find someone that was a better fit for the Planning Board. One of the firms that I work with is MRB. I work with them in the Town of Avon, and they have a gentleman by the name of Lance Brabant, who is a Planning Specialist. He works with planning boards, that is his function with regard to the review of site plans and special use permits for all different kinds of projects, from small commercial to very large, complex commercial things. His firm has varying degrees of engineering and architectural expertise on staff. So, what he does is come to the planning board meetings and familiarize himself with the procedure and protocol and code of the given community and then work with a planning board to help facilitate the review of the projects based on what their needs are. He's a very competent guy and has a really good personality. He likes working with boards and takes direction well. He tries to meet the needs of the board rather that takeover and change processes that communities are used to. I suggested to Jerry and Joe that maybe we have a conference call with Lance and have some conversation about whether it might be a good fit. One of the other planning board members, Chris Wall participated in that conference call as well. The conference call I thought, was good, it seemed that Joe and Chris were comfortable with what they were hearing from Lance, and certainly based on my familiarity working with him for four or five years on lots of different kinds of matters, I think he'll be a real asset, with a lot of assistance to the planning board. I think the fit is really going to be great. So, my recommendation to Jerry and Joe was if they were comfortable, to consider engaging MRB for that position that was previously filled by TY Lin. Again, MRB has a lot of expertise. They do have an engineer who works on a lot of solar things, including the big Article 10 projects, so I think it might be a good fit. What Joe has asked on behalf of the planning board, is that the Town Board give their blessing to entering into an engagement agreement with MRB and Lance Brabant. Lance sent over the proposed engagement letter this afternoon, I think Jerry has it. The terms of it are I think favorable, the cost is going to be probably more modest that what we were paying with TY Lin. I don't think you're going to sacrifice anything in terms of expertise, and certainly he's going to work better with the boards and that's going to facilitate these projects being much more efficient. I think the applicants are going to be happy because we're not going to be delayed by our consultant. Our consultant is going to help make things more efficient, not less.


We received a letter this afternoon from Kirk Richenberg and he had some questions. Part of this deals with TTHMs and test results and so on. I think George, I read some of this to you just before the meeting, can you comment on the averages and what we are getting right now.

#### 28:36- George Worden

On the TTHMs everyone knows that we're at the mercy of our supplier of getting a low number from them. Anytime we get something above a 50 we run a risk, toward Fowlerville, of getting an 80 on our TTHMs. So basically we're kind of at the mercy of the supplier there. It hasn't gotten any worse since we've done any of the expansions or anything. It's going to be interesting because it is temperature related. The other thing is, it doesn't just affect how much water we're using, it's also on how long it sits in their 3 million gallon reservoir over there. You have to take into consideration too when the college is in session they use a lot more water in Geneseo than when they're not. So, that kind of affects us as well, that is one reason I think its temperature related. We are doing the best we can, everything that goes to our tanks is getting treated with the Grid Bee which includes the ones on Tuttle Road and the one up on Covington.

I have the following questions for which I would like to be answered.

In the 2019 Annual Water Quality Report the TTHMs averaged just under the allowable limit. What were actual test results for each date the samples were taken? It has been stated many times at public meetings by the town engineering firm and the water department leader that this TTHM problem would be resolved with the increase in water usage by adding users. Why is this not the case? Also when the town applied for the grant and/or loan for the upcoming Anderson road water project did the town reveal the 2019 TTHMs were above the EPA limits? More important has the town informed all the potential new customers of this ongoing problem?

What was the reason for all the ditch work and the new driveway pipe at and near the first house north of Linwood Rd on Federal Rd? It was my understanding that this ditch was all taken care by the contractor who installed the water main to this area. How does the town board address problems with contractors on past projects and with these contractors awarded future and upcoming projects? Will this be considered in the Anderson road water project?

Was there a public meeting held for the opening of the bids for Anderson Rd water project?

Is the town board considering any possible ways for virtual public input at public meetings?

#### 30:07- George Worden

That's the best we can do, we have to stay under an 80 with a limit. We do the best we can but sometimes we have only a few points to work with because we have received in the high 70's from Geneseo. When we get those reads we know we are going to be in trouble.

#### 30:31- Supervisor Deming

One of the other questions is when we applied for a grant and a loan for the Anderson Road project, did the town reveal the 2019 TTHMs were above the EPA limits?

#### 30:51- Supervisor Deming

I don't actually recall that. Believe me Rural Development went through everything, and I don't think they missed a thing. I do not remember anything being discussed about TTHMs at that time. The other question is, was the potential new customers informed about the TTHMs? Yes, that was at the public hearing. Somebody brought that up and asked that question and it was addressed at the meeting, so they were aware. Plus the report is published each year for all the residents to view.

George, you recently did some ditch work and installed a new driveway pipe near the first house north of Linwood Road and Federal Road...does it have anything to do with the contractor when the work was done up there?

#### 31:52- George Worden

It does not. The gentleman that lives there called me up one night because it was running, and it was raining at the time, he said he was having problems with water in his front yard and his drainage all goes out the front of the house, eaves trough and everything. So I went out and took a look at it and noticed it wasn't draining from the north side of his driveway properly, that was because of a driveway pipe that was bad. To be honest when a driveway pipe goes bad, it is our responsibility. Then I had other conversations with this gentleman and he asked if there was any way I could get the driveway pipe deeper. I told him we couldn't answer that question right then. The water was running down the ditch properly other than where we did put some stone back in the ditch with the wing, unfortunately this winter. So we went up with a laser and was able to lower his driveway pipe by six inches and still have fall to the crossover pipe that goes under Linwood Road I did do this for him like I would do for anyone that asked us if it was possible to do. So, we cleaned the ditch and lowered the ditch and replaced his driveway pipe.

How does the town board address problems with contractors on past projects and with these contractors awarded future and upcoming projects? Will this be considered in the Anderson Road water project? ... I'm not sure, I don't think right now we have any past projects or problems with any contractors that I am aware of. With regard to the smaller projects like Solar Park and OYA, his thought is that from an efficiency standpoint and a financial standpoint, it doesn't make sense for him to be very involved until possibly when it comes time to issue permits, if Carl needs his assistance. The permit requirements for the solar projects are very particular and if Carl is not familiar with them Shawn would be willing to assist on an as needed basis. He really sees himself being in the background until needed on those things, and with regard to the Article 10 when needed when that project starts to take off.
