Mr. Connolly left the hearing open for comments for 15 minutes. There were none. He closed the hearing at 7:15 and opened the Zoning Board meeting and asked for approval of the August 18 minutes.

Mr. Connolly asked the board if they had any questions or comments. There were none. Mr. Connolly mentioned their application was very complete.

Criteria for area variance and answers from board

1. Whether an undesirable change will be produced in the character of the neighborhood or a detriment to nearby properties will be created by the granting of the area variance.

2. Whether the benefit sought by the applicant can be achieved by some method, feasible for the applicant to pursue, other than an area variance.

3. Whether the requested area variance is substantial.

4. Whether the proposed variance will have an adverse effect or impact on the physical or environmental conditions in the neighborhood or district.

5. Whether the alleged difficulty was self-created; which consideration shall be relevant to the decision of the board of appeals, but shall not necessarily preclude the granting of the area variance.
