
Committee Process

- Legal evaluation of process







Water Features




Aquifer Map




Miscellaneous Environmental Features




Zoning Districts






Town Road Use Agreement

Zoning Code Amendments

- Revised Definitions
- Revisions to Permitted Uses
- Minor Changes addressing Performance Standards
- NEW SECTION 618 Natural Gas & Petroleum Extraction





Principal Aquifer Overlay District

- Based upon Published NYSDEC Map
- Identifies a Significant Town Environmental Resource
- Establishes 11 Prohibited Uses including:
 - Storage of hazardous / toxic materials
 - Underground Injection of wastes
 - Surface application of wastes not included in a Comprehensive Nutrient Management Plan
 - Drilling Operations for Commercial Use or Re-sale
