PROVIDING A FOUR YEAR TERM FOR THE  
ELECTIVE OFFICE OF TOWN SUPERVISOR  
OF THE TOWN OF YORK

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF YORK AS FOLLOWS:

1. TERMS OF OFFICE:

The term of office of the Town Supervisor of the Town of York elected at the biennial Town Election of 1995 shall be four (4) years. Said four-year term shall commence on the first day of January, 1996.

2. ELECTION OF THE TOWN SUPERVISOR:

At the biennial town election of 1999 and every four (4) years thereafter, the term of the Town Supervisor elected at such election shall be four (4) years.

3. EFFECT ON OTHER LEGISLATION:

This local law shall supersede any local law, resolution or statute.

4. PUBLIC APPROVAL

This local law shall be submitted for approval to the electors of the Town of York at the next election held not less than sixty (60) days after its adoption.

5. WHEN EFFECTIVE:

This local law shall take effect immediately upon filing with the Secretary of State after approval by a majority of the electors voting thereon in accordance with the requirements of the Municipal Home Rule Law and Chapter 230 of the Laws of 1981.


